### Section (I) - Submission of Registration of Intent

Balloting will be used to determine the order of priority in selecting the specified residential properties. Any person interested in purchasing any of the specified residential properties ("the registrant") must follow the procedures below:-

1. A registrant must **personally** submit the following:-

- (a) only one Registration of Intent duly completed and signed by the registrant;
