 Transitional Loan Stamp Duty Payment (Applicable only to the Purchaser who is individual or limited company incorporated in Hong Kong with all its shareholder(s) and director(s) being individual(s))
 - (I) 凡於2015年6月30日或之前簽署臨時買賣合約,買方可向指定財務機構申請過渡性貸款(『過渡性貸款』)。 Where the preliminary agreement for sale and purchase is signed on or before 30 June 2015, the Purchaser may apply for a Transitional Loan (the "Transitional Loan") from the designated financing company.
