1. The sale of the specified residential properties will be divided into the following 2 sessions (namely Session A and Session B). Any person interested in purchasing any of the specified residential properties (the "**registrant**") may participate in both Session A and Session B (save in the circumstances provided in paragraph 7 below), or only in Session B.

Section (II) - Submission of Registration of Intent

Balloting will be used to determine the order of priority in selecting the specified residential properties. Registrants must follow the procedures below:-

The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent:-

 - (ii) if the registrant is a corporation, two (2) specified residential properties.

Upon completion of the procedures stated in this paragraph 2, the registrant will be given a receipt of Registration of Intent (the "**Receipt**").

Section (III) - Procedures for Session A

- 3. Registrants interested in participating in Session A in the manner prescribed in the Abstract in Section (I) above must follow the procedures specified in Sections (I), (II), (III) and (V). If in the end the registrant has not purchased any specified residential property in Session A, that registrant is still eligible to participate in Session B to select and purchase the remaining specified residential properties which are still available for sale.
- 4. Registrant interested in participating in Session A (or his/her/its authorized person) must attend the designated venue after this Sales Arrangement is made available till 16 June 2015 (both dates inclusive) during office hours (from 2:00 p.m. to 8:00 p.m. on each day, except for 16 June 2015 the office hours will be from 11:00 a.m. to 2:00 p.m.) to complete the following procedures:-

 - (i) The first round balloting for Session A will take place at or after 4:00 p.m. on 16 June 2015 at the designated venue for the purposes of dividing the Session A Registrants into one or more group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong. Session A Registrants will not be notified separately of such changes.
 - (ii) The results of the first round balloting, including "registration number", "division of group", "check-in timeslot for each group" will be posted by the Vendor at the designated venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Session A Registrants will not be separately notified of the ballot results.
 - (b) <u>Second round balloting (for determining the order of priority of Session A Registrants in selecting and purchasing the specified residential properties in Session A)</u>
 - (i) The second round balloting for the group(s) of the Session A Registrants will take place on the first date of sale in batches at the designated venue at the beginning of the relevant "check-in timeslot for each group" as posted by the Vendor pursuant to paragraph 5(a)(ii) above.  - (ii) Before the second round balloting for each group takes place, the Session A Registrants in that group shall be further divided into two sub-groups: the first sub-group consists of Session A Registrants comprising individual(s) only; and the second sub-group consists of the remaining Session A Registrants. Session A Registrants in the first sub-group will have priority over Session A Registrants in the second sub-group in the selection of the specified residential properties. The Vendor shall carry out the second round balloting for the first sub-group and the second sub-group in that group respectively.
 - (iii) For the purpose of verification of identity, the Session A Registrants (if the Session A Registrant is a corporation, then **all directors** of that corporation) must bring along his/her/their original H.K.I.D. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of the lobby on 3/F and/or 10/F and/or 86/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the "**Additional Venues**") to accommodate some of the Session A Registrants by making announcement and/or posting notice(s) at the designated venue and the Additional Venues. Session A Registrants who arrive at the designated venue or (if directed by the Vendor) the Additional Venues beyond their "check-in timeslot for each group" shall not be eligible to participate in Session A.
 - (iv) For the purpose of the second round balloting, each Registration of Intent shall be allotted one lot. - 7. Section (IV) - Procedures for Session B

- 8. Registrants interested in purchasing any of the specified residential properties in Session B in the manner prescribed in Section (I) above must follow the procedures specified in Sections (I), (II), (IV) and (V).
- 9. Balloting for Session B will take place in batches:-
 - (a) First round balloting (for dividing all registrants into one or more group(s))
 - (i) The first round balloting will take place at or after 4:15 p.m. on 16 June 2015 at the designated venue for the purposes of dividing the registrants into one or more group(s). All valid Registrations of Intent submitted before the closing time for submission as stated under Section (II) above will be included automatically in the balloting. The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong. Registrants will not be notified separately of such changes.
 - (ii) The results of the first round balloting, including "registration number", "division of group", "check-in timeslot for each group" will be posted by the Vendor at the designated venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Registrants will not be separately notified of the ballot results.
 - (b) <u>Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties in Session B)</u>
 - (i) The second round balloting for the group(s) of registrants will take place on the first date of sale in batches at the designated venue at the beginning of the relevant "check-in timeslot for each group" as posted by the Vendor pursuant to paragraph 9(a)(ii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue. Registrants will not be notified

separately of such changes.

- (ii) Before the second round balloting for each group takes place, the registrants in that group shall be further divided into two sub-groups: the first sub-group consists of registrants comprising individual(s) only; and the second sub-group consists of the remaining registrants. **Registrants in the first sub-group will have priority over registrants in the second sub-group in the selection of the specified residential properties**. The Vendor shall carry out the second round balloting for the first sub-group and the second sub-group in that group respectively.
- (iii) For the purpose of verification of identity, the registrants (if the registrant is a corporation, then **all directors** of that corporation) must bring along his/her/their original H.K.I.D. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of the Additional Venues to accommodate some of the registrants by making announcement and/or posting notice(s) at the designated venue and the Additional Venues. Registrants who arrive at the designated venue or (if directed by the Vendor) the Additional Venues beyond their "check-in timeslot for each group" shall not be eligible to participate in Session B.
- (iv) For the purpose of the second round balloting, every Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent. Once a lot allocated to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and treated as null and void in the same balloting. The number of specified residential property(ies) that the registrant of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant intends to purchase as indicated in the Registration of Intent. The results of the second round balloting, including "registration number" and "ballot result sequence" will be announced and/or posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
- 10. After the second round balloting, the selection and purchase of the specified residential properties in Session B shall only commence <u>after</u> Session A has been completed. The Vendor may postpone the time for selection and purchase of the specified residential properties in Session B pending completion of Session A. Registrants shall proceed to select the specified residential properties in accordance with the rules below:-
 - (a) Registrants (if the registrant is a corporation, then **all of its directors**) shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the "ballot result sequence" and in an orderly manner and within reasonable time. Registrants shall select and purchase the specified residential properties in compliance with the criteria set out in Section (I) above.
 - (b) If a registrant has successfully selected the specified residential property(ies) in accordance with the criteria set out in Section (I) above, the registrant shall **personally** enter into preliminary agreement(s) for sale and purchase of the selected specified residential property(ies). If the Purchaser is a corporation, all the selected specified residential properties must be covered under the same preliminary agreement for sale and purchase. Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential property(ies), the registrant may request the Vendor on spot to add his/her close relative(s) as joint purchaser(s) and/or delete the registrant's name from the preliminary agreement(s) for sale and purchase in accordance with the requirements under paragraph 14 below.

Section (V) - General Provisions (applicable to both Session A and Session B)

- 11. The following apply to registration:-
 - (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration in a Session will not be accepted.
 - (b) The Registration of Intent is personal to the registrant and shall not be transferable.
 - (c) The order of submission of the Registration of Intent and the order of completion of the procedures to participate in Session A will not have any impact on the order of priority for selecting the specified residential properties in Session A and Session B.

- (d) (For corporate registrant) If after the submission of Registration of Intent, there is any change in the composition of the board of directors of the corporation, then the relevant Registration of Intent shall become invalid immediately and the registrant **shall not be eligible to participate in any Session**.
- (e) In case of dispute, the Vendor reserves its right to determine whether a Session A Registrant is eligible to participate in Session A, whether a registrant is eligible to participate in Session B and whether a Registration of Intent is valid and should be included in balloting.
- (f) For the avoidance of doubt, if a registrant has already submitted a Registration of Intent in accordance with Section (II) above, it is not necessary to make any further indication to the Vendor before a registrant is entitled to participate in Session B.
- 12. Arrangement on cashier order(s):-
 - (a) The cashier order(s) submitted in accordance with paragraph 2(b) above or (if applicable) paragraph 4(b) above will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies). The registrants (including the Session A Registrants) must also, on the first date of sale, in respect of <u>each</u> specified residential property that he/she/it purchases, prepare a cashier order in the sum of HK\$500,000 and made payable to "WOO KWAN LEE & LO" as further part payment of the preliminary deposit for the purchase of the specified residential property. The balance of the preliminary deposit for the purchase of the specified residential property(ies) may be paid by personal cheque(s) upon signing of the preliminary agreement for sale and purchase.
 - (b) If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, the **unused cashier order(s)** will be available for collection by the registrant (or his/her/their authorized person) at the designated venue from **18 June 2015 to 19 June 2015** (both dates inclusive) during office hours (from **2:00 p.m. to 8:00 p.m.** on each day). The registrant must bring along his/her/their H.K.I.D. Card(s)/Passport(s) (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by authorized person), (if applicable) copy of Business Registration Certificate, the original Receipt and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.
- 13. The Vendor shall not be responsible to the registrants (including the Session A Registrants) for any error or omission contained in the ballot results.
- 14. The following apply to addition of "close relative(s)" of the registrant(s) as purchaser:-
 - (a) "close relative(s)" means spouse, parents, children, brothers and sisters of the registrant.
 - (b) If the registrant comprises individual(s) and purchases <u>one (1)</u> specified residential property: before signing the preliminary agreement for sale and purchase, such registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of <u>ALL</u> the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor's satisfaction whose determination shall be final.
 - (c) If the registrant comprises individual(s) and purchases <u>two (2)</u> specified residential properties and the registrants requests to have <u>one (1) preliminary agreement for sale and purchase</u> for all those properties: before signing the preliminary agreement for sale and purchase, the registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of <u>ALL</u> the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor's satisfaction whose determination shall be final.
 - (d) If the registrant comprises individual(s) and purchases <u>two (2)</u> specified residential properties and the registrants requests to have <u>more than one (1) preliminary agreement for sale and purchase</u> for those properties:-
 - (i) Before signing the preliminary agreement for sale and purchase in respect of the <u>first</u> specified residential property, a registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of <u>ALL</u> the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor's satisfaction whose determination shall be final.
 - (ii) Before signing the preliminary agreement for sale and purchase in respect of the **second** specified

residential property, a registrant may request the Vendor on spot to:-

- (1) add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers; or
- (2) add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as purchaser(s), and delete the registrant's name from the preliminary agreement for sale and purchase

provided that the additional individual(s) must be the close relative(s) of <u>ALL</u> the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor's satisfaction whose determination shall be final.

- (e) All the person(s) signing the preliminary agreement for sale and purchase must sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add and/or delete any individual(s).
- 15. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting). For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase on a first come first served basis save and except that if a purchaser intends to purchase Unit B in Tower 8, such purchaser must also purchase a property in Unit A in Tower 6.
- 16. The Vendor reserves the right to close the designated venue and (if applicable) the Additional Venues at any time if all the specified residential properties (except all Units B of Tower 8) have been sold out.
- 17. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 8:00 p.m. on any date on which the Registration of Intent may be submitted, on any date on which the procedures to participate in Session A may be processed, the date on which the first round balloting for Session A and/or Session B will take place and/or the first date of the sale, then, for the safety of the registrants and the maintenance of order at the designated venue and/or (if applicable) the Additional Venues, the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent and/or for completing the procedures to participate in Session A, the first round balloting for Session A and/or Session B and/or second round balloting for Session A and/or Session B and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the designated venue and/or (if applicable) the Additional Venues. Details of the arrangement will be posted by the Vendor on the website (www.ultima.com.hk) designated by the Vendor for the Phase. Registrants will not be notified separately of the arrangement.

On 18 June 2015 and thereafter:

- 18. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting). For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase on a first come first served basis-save and except that if a purchaser intends to purchase Unit B in Tower 8, such purchaser must also purchase a property in Unit A in Tower 6.
- 19.
